

## **Denominationslose Pfingstler, evangelikale charismatische Katholiken und wiedergeborene Fundamentalisten: Die Pfingstbewegung in den Philippinen (Maltese)**

### **Zusammenfassung**

Die weltweite pfingstlich/charismatische Bewegung stellt eine der schillerndsten und am rasantesten wachsenden Erscheinungen des gegenwärtigen Christentums dar. Für die Erforschung dieser Bewegung bieten die Philippinen, die sogenannte „einzig christliche Nation Asiens“, einen besonders spannenden Kontext. Religionsgeschichtlich blickt der Archipel auf muslimische Missionare im 14. Jh., sowie auf Christianisierungsunternehmungen, durch spanische Mönchsorden bzw. US evangelikale Missionare zurück, die mit Kolonialisierungs- und Expansionspolitik im Pazifik verflochten sind. Heute bezeichnen sich ca. 40% der Gesamtbevölkerung als pfingstlich/charismatisch (PEW 2006) – die Mehrheit sieht sich jedoch nach wie vor als Teil der römisch-katholischen Kirche. Vor diesem Hintergrund lassen sich daher sowohl das Verhältnis der pfingstlich/charismatischen Bewegung zu evangelikalen Strömungen und zur katholischen Hierarchie diskutieren, als auch ihr Verhältnis zu bewaffneten muslimischen Separatisten und zur kommunistischen Volksarmee, die einen blutigen Guerillakrieg gegen die Regierung führen.

Anhand von einschlägiger Literatur und Primärquellen (Videoaufzeichnungen, narrative Interviews und Schulungsmaterial) wird das Seminar sowohl in Methoden- und Theorieprobleme der Erforschung der Pfingstbewegung einführen, als auch verschiedene Themen, wie narrative Identitätskonstruktion, Medien, Interreligiosität, Ökonomie, Politik und „capacity building“ behandeln.
